From January 1, 2019 through December 31, 2019, the Butler County Detention Facility has a reported rate of 0.05% regarding substantiated in custody sexual abuse or sexual harassment for the entire population of over 200 incarcerated individuals.

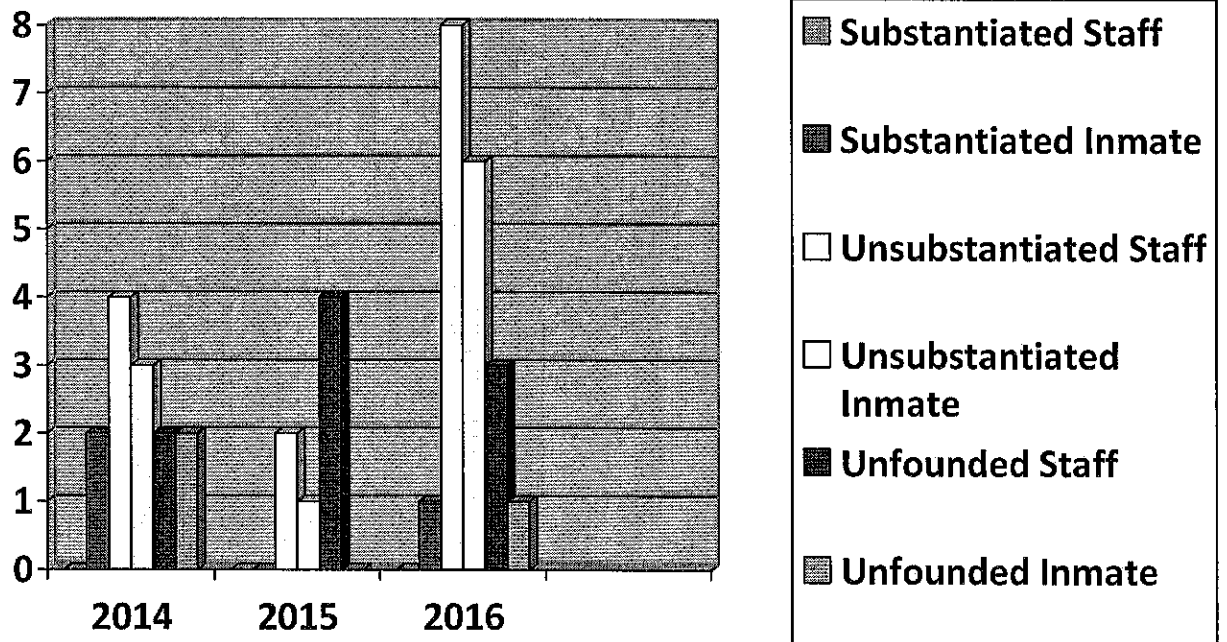

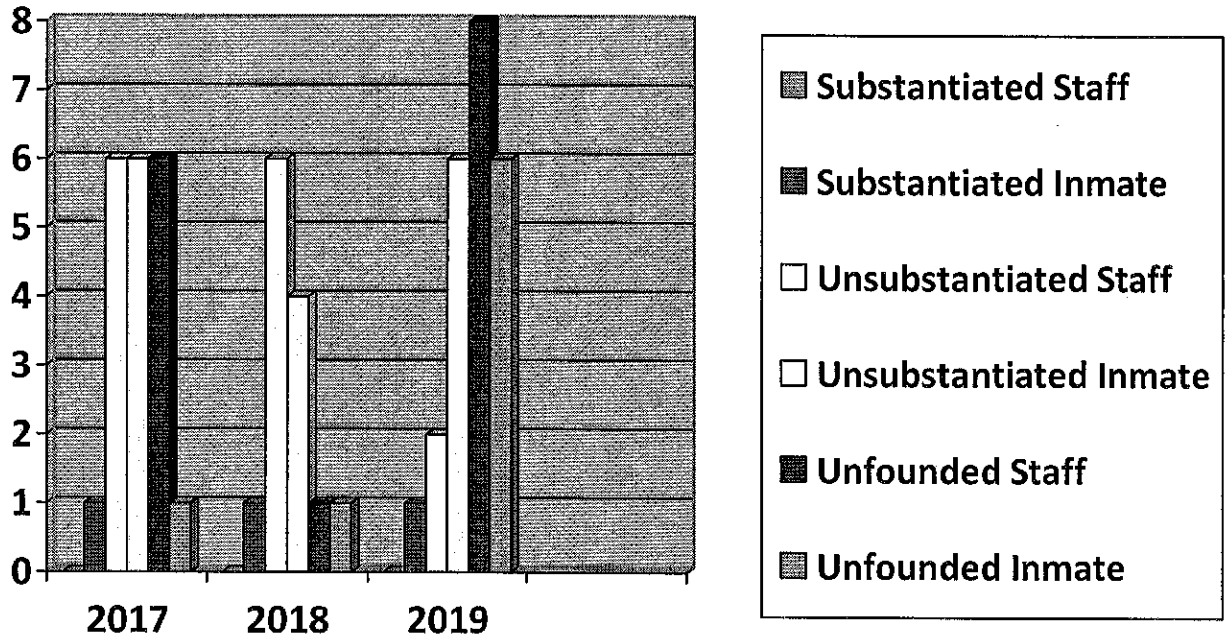

- January 1, 2019 instituted a revised staffing plan to address non-sexual abuse related incidents to include rotating dayroom times by run, in an effort to better manage/supervise the inmate population. As well as to go from 7 staff on shift from 2145 hours to 0600 to 9 staff and to man B pod at all times whenever possible.
- January 2019 due to the recording/play, back issues the NVR's for the camera's all NVR's were reformatted to temporarily correct the issues until new NVR's can be installed.
- February 2019 completed installation of new High Definition NVR's from camera system with more storage capacity. As well as replacement of high definition cameras for six cameras.

- Higher resolution camera replaced in Dorm
- Moved cameras in Dorm and Laundry room to better vantage points
- Male/female signs on Booking cell doors to make busy booking staff better aware of gender of each inmates housed within.
- In the future, we will be replacing camera with 4k cameras.
- Annual Employee PREA Training occurred in June
- Information regarding how to better detect, respond, and prevent sexual abuse and sexual harassment has been periodically distributed throughout the year by email as well as gone over during shift briefings.
- August PREA Audit conducted of compliance.
- Added six camera's one in each male housing unit storage room and inside of c104 and c107 sally ports in response to a terminated staff member due to misconduct identified blind spots. 6 additional cameras were installed on 7/25/2019
- Added section during revisions of Deputy Field Training Manual to include PREA employee training

The Butler County Detention Facility publishes an Annual Report regarding in custody sexual abuse and sexual harassment as well as appropriate plans to improve the agency's prevention, detection, and response efforts. Personal identifiers and specific details related to the complaint were redacted in order to protect the confidentiality of the individual as well as the safety and security of the facility.
